

User Agreement for ILONSI AB (publ) with organization number 559055-0587

This agreement ("User Agreement") applies between ILONSI AB (publ), organization number 559055-0587 ("ILONSI AB (publ)"), and You ("User"). By accepting these terms in the agreement and if you have subsequently been approved by the advertiser, you become an approved User of ILONSI AB (publ)'s service ("Service") to act as an intermediary for advertising. The User agrees to all the terms in this agreement and its annexes in connection with joining the service and/or an affiliate program. This version of the User Agreement replaces all previous agreements between the parties.

The Service

An approved User has the right to provide space on their social media or other marketing channel on the internet for links, banners, advertisements, and similar for advertisers who have an affiliate program registered with ILONSI AB (publ). ILONSI AB (publ) and/or the advertiser may, without warning or notice, change the terms for or terminate an affiliate program. It is the User's responsibility to follow the changes in the terms for the affiliate programs to which the User is connected. ILONSI AB (publ) has the right to change or completely or partially terminate the Service at any time without prior warning or notice. In the event of such actions, the User will be notified via email and publication on ILONSI AB (publ)'s website.

Form of Agreement

The User participates in ILONSI AB (publ)'s service completely free of charge. In connection with payments to the User, costs may be charged to the User according to a price list applicable at the time of payment. The agreement does not imply that the User is employed by ILONSI AB (publ). The agreement is valid until further notice and can be terminated by both parties immediately without notice. ILONSI AB (publ) has the right to change the agreement at any time during the agreement period, and ILONSI AB (publ) will inform the User of these changes. Changes to the agreement will be communicated to the User via email and publication on ILONSI AB (publ)'s website.

Rights

ILONSI AB (publ) owns all copyrights, usage rights, and all software associated with the Service, and the User has the right to use the Service only in accordance with the agreed terms in this agreement. The User does not hold or acquire any form of intellectual property rights under this agreement.

Advertiser's Rights

The advertiser has the right to determine the terms for the User's participation in an affiliate program, which applies in parallel with this agreement, and these terms can be changed at any time. The advertiser also has the right to terminate the cooperation and change the terms and compensation for cooperation with the User.

ILONSI AB (publ)'s Undertakings

ILONSI AB (publ) undertakes under this agreement and within the framework of the Service to record and report traffic generated within the applicable affiliate program to the User's platforms and to pay compensation based on this traffic as per the Agreement.

User's Undertakings

The User undertakes to keep confidential information securely and to immediately inform ILONSI AB (publ) if there are suspicions that unauthorized persons have gained knowledge of or used confidential information. The User agrees to comply with all applicable laws and regulations on their platforms and guarantees that all data provided to ILONSI AB (publ) is complete, correct, and consistent with actual circumstances. The User guarantees that they have the rights to all content on their platforms or have explicit consent from the rights holder for its use. The User also guarantees that the content on their platforms does not infringe on the rights of any individual or legal entity, including intellectual property rights. The User agrees not to generate or assist in generating fake traffic to the advertiser's platforms, and no payment will be made for such traffic. Such fake traffic may result in a compensation claim against the User.

The User is responsible for accepting the details and terms for each individual affiliate program before publishing advertising material from an affiliate program. The User grants ILONSI AB (publ) free access to administer the content of advertising spaces and materials if they are active and used on the User's platforms.

Only one account is allowed per company or individual. Exceptions may be made with ILONSI AB (publ)'s consent.

Right to Update Terms

ILONSI AB (publ) reserves the right to update, modify, or change the terms of this User Agreement at any time. The User will be notified of such changes via email and publication on ILONSI AB (publ)'s website. It is the User's responsibility to regularly review the User Agreement to stay informed of any changes. Continued use of the Service after changes are made constitutes the User's acceptance of the revised terms. If the User does not agree with the updated terms, they should cease using the Service.
